STRICTLY ESSENTIAL TRAVELS ONLY

Even Bataan residents will not be allowed to enter the province unless the purpose of their travel falls under the so-called "essential travels".



Only OFWs will be allowed to enter Bataan on condition that they will undergo the 14-day quarantine period in a designated isolation center in their respective municipalities.

AUTHORIZED PERSONS ESSENTIAL TRAVELS

ESSENTIAL GOODS



Delivery personnel of cargoes - with or without load (maximum of 3 including the driver)



Employees working at manufacturing establishments engaged in the production and distribution of the following:

- Food
- Essential and hygiene products (soap and detergents, diapers, feminine hygiene products, tissues, wipes, toilet papers and disinfectants)
- Medicines and vitamins
- Medical products such as PPEs, masks, gloves and others



Logistics/Warehouse establishments employees



Delivery services personnel of food, water, medicine, and other basic necessities

DAILY ESSENTIALS

- Technical Service Support Crew
- ATM Service Provider Crew
